- 5. Immediate solve the Pensioners issue like Pre-2007 pensioners benefits and settlement of Pensioners claims timely.**
- 6. Filling up of the Vacant Post through Departmental Examination like TTA, TM, JTO, JAO etc.**
- 7. To resolves the Problems of Casual & Contractual Labourers .**
- 8. Immediately vacate the rented Buildings and use the vacant departmental quarters as vice-versa as per guidelines of BSNL C.O.**
