CASUAL / CONTRACT WORKERS IN WEST BENGAL ARE ON THE STRUGGLE AGAINST THE CAUSE.

One day strike on 12th February'2010 at the call of 12 July Committee and CPSTU, West Bengal is going to be organized. Strike preparation was almost completed throughout West Bengal Telecom Circle in BSNL Establishments. After the completion of Centralize Convention of BSNLEU & BSNLCMU Circle Unions of Casual/Contract workers, District wise joint conventions of BSNLEU & BSNLCMU were held throughout West Bengal Telecom Circle at Jalpaiguri, Siliguri, Raiganj, Suri, Berhampore, Asansol, Kolkata, CTO, Krishnagar, Bankura including ETR Divisions. It has been decided that Circle/District/Branch office bearers of BSNLEU W.B. Circle will take leave on 12th instant and will take part in the Dharna programme along with the striking Casual/Contract workers from morning. Other members of BSNLEU will join enmass in the Dharna from 1200hrs. to 1600hrs. throughout West Bengal Circle.

Today the 10th instant a massive rally will be organized from Metro Channel to Labour Commissioner Office, Nizam Palace, Kolkata. Thousands of Non-regular workers of different establishments of Central Govt./State Govt./ BSNL & other PSUs along with regular employees will take part in the Rally at 1600 hrs.

Therefore Circle Office bearers , District /Branch Secretaries are requested to take utmost organizational effort along with Casual/Contract leadership so that one day strike on 12th February'2010 would be a grand success.

Wage Revision :- After the approval from Management Committee meeting, the agreement of Wage Revision of non-executives will be placed before BSNL Board in its meeting may be held on 23rd/24th February'2010. Thereafter the files will go to DOT.
