Sub: JTO Examinations for TTA Cadres.

Respected Sir,

You are aware of the fact that after a long period the BSNL Corporate Office has decided to conduct JTO examination. The Corporate Office has already announced the schedule of the JTO (Electrical) examination which will be held in the month of May, 2011. But it is surprising to note that the BSNL CO did not take any effort to conduct examination for JTO (Telecom) as well as for other Stream/Branch till date. As a consequence the eligible TTA candidates are very much aggrieved with the decision of the BSNL CO not to conduct any such examinations during last 10 years. Recently it is learnt that due to completion of the court case there is no complicity to conduct JTO examination at present. Hence the Circle Union requests the Circle Authority to take up the issue of JTO examinations with the appropriate level and also declaration of the schedule of the examination at the earliest possible opportunity.

I am also constrained to bring the following issues for your kind notice.

A) It was decided in the National Council at Delhi that the service condition for appearing in a JTO examination by a TTA will be 7 years instead of 10 years. But it is observed that though the Management has amended the age criteria from 10 to 7 years and also has issued the order in this regard but they did not change the previous criteria of 10 years during publication of Circular for JTO Examination.

B) The BSNL CO has published notification for JTO LICE on 21/12/2009, but in that notification the BSNL Management counted the vacancy period up to 31/03/2009 and fixed the cut off date for counting Qualifying Service condition as 01/07/2009, due to which very few employees of WB Circle were eligible for this examination against more than 450 JTO vacancies under 35% quota.

In view of the above the Circle Union has the specific proposal that BSNL CO should maintain the eligibility criteria for JTO examination as 7 years as per the decision of the National Council meeting and also the BSNL CO should announce the JTO examination on the basis of the vacancies occurred up to 31/03/2011, so that the TTAs who have joined the Department on or after 01/10/2000 will get the chance to appear in the JTO examination.

Hope that You will surely take up the case with the appropriate authority for the benefit of these young energetic, skilled and efficient fellows.
