**Dear Comrades,**

The 2<sup>nd</sup> Circle Working Committee (Extended) Meeting of the BSNLEU, WB Circle was completed successfully at Berhampore, Murshidabad. Comrade Parimal Sarkar has presided over the meeting. Almost all the District & Branch Secretaries (more than 100 in number) were present in the Two days meeting. Numbers of important agendas were discussed in the meeting elaborately by the leaders and organizers. After threadbare discussions the following decisions were taken for immediate implementation.

- 1) **Organise Campaign Week from 23-30 December, 2010:-** The Dist/Br. Secys are requested to organize extensive campaign programme from 23/12/10 to 30/12/10 on the issues of all time great scam of 2G Spectrum in Telecom and the silent role of UPA-II Government, struggle and whole hearted efforts of the BSNL employees under the leadership of BSNLEU to make BSNL financially viable and profitable in the coming days, amongst our members and the General people. At the same time the organizers should emphasize the issues of the successful strike of BSNL Workers mainly against Disinvestment and VRS on 01<sup>st</sup> & 2<sup>nd</sup> December, 2010 in their campaign.
- 2) **Organise Campaign against the atrocities of the reactionary forces of West Bengal:-** The reactionary forces of West Bengal is trying to destroy the peaceful existence of the People of West Bengal in various ways. Especially the Hill region and some corners of our state are badly affected with 'BANDH' and shedding blood everyday due to the miscreants of this reactionary force. They do not even spared the employees of BSNL as well as other Central Govt. and State Govt. establishments of this state. These Criminal forces are trying their best to impose "Black Days" again in this State. You are therefore requested to organize all out propaganda programme against these atrocities at all level.
- 3) **Observance of Demand Day on 21/12/10:-** The All India Committee of Public Sector Trade Unions has decided to organize All India Demand Day for the just demands of Casual/Contract Labourers on 21<sup>st</sup> December, 2010. The Dist/Br. Secys are directed to extend their full solidarity and cooperation on the demand day on 21/12/10 with their members to make the programme successful.
- 4) **5<sup>th</sup> Membership Verification:-** You are already aware of the fact that the date of the 5<sup>th</sup> Membership Verification has been fixed on 01/02/2011. The Branch Unions and the District Unions are directed to organize meeting at Unit Level and at Branch and District levels respectively under their jurisdiction within 10<sup>th</sup> January, 2011. The leaders/organizers are directed to emphasize mainly on the continuous and uncompromising fight of BSNLEU to save BSNL against disinvestment, against the policies of the UPA-II Govt. to give VRS to the BSNL employees and also against the retrograde recommendations of Sam Pitroda to diminish BSNL Department. You are also requested to highlight the beneficiary aspects of Wage revision, NEPP etc to the Employees and give the employees a patient hearing if any question arises. At once form Booth Committee/ Election Committee at your District. Organise District Conventions/General Body Meeting on the eve of Membership Verification before 28<sup>th</sup> January, 2011 positively. Circle Leaders will be present if informed in time.
- 5) **Clear all outstanding Dues:-** The District Secretaries are directed to remit all dues (e.g. CHQ Building Fund Quota, Circle Org Fund'10 Quota, Cost of "Samayer Pathe" etc.) immediately to the Circle Union to enable us to supply all necessary articles relate to 5<sup>th</sup> MV.
- 6) **Organise Demonstration Programme on 5<sup>th</sup>, 6<sup>th</sup> & 7<sup>th</sup> January'11:-** It is observed that on the plea of austerity or financial curtailment and also on the pretext of making BSNL financially viable, the Authority is taking some measures without any prior information or discussions with the recognized union at any level, decisions of the Council Meetings were not properly executed. Therefore the Circle Union has decided to organize Demonstration against the attitude of the Authority to organize Demonstration Programme before CGM ETR on 05/01/2011, CGM WBT Circle on 06/01/2011 and CGM ETP on 07/01/2011. Similar programme should be organized at the District by the District Unions at GM/TDM Level. Make the programme all successful.
