ONE DAY STRIKE ON 12TH FEBRUARY, 2010 OF CASUAL/ CONTRACTUAL LABOURS – OUR ROLE

One day strike at the call of Central Trade Union, 12 July Committee and CPSTU, West Bengal will be organized on 12th February, 2010. Strike preparation is almost complete through out West Bengal Telecom Circle in BSNL Establishments. After the completion of convention of CCBU of West Bengal at CTO, Kolkata, District wise joint conventions of BSNLEU & BSNLCMU were held through out West Bengal Telecom Circle at Jalpaiguri, Siliguri, Raiganj, Suri, Berhampore, Asansol, Kolkata, CTO, Krishnagar, Bankura including ETR Divisions.

It is decided that Circle /District/Branch office bearers of BSNLEU, W.B Circle will take part in Dharna programme along with the striking Casual/Contract workers from the morning of 12.2.2010. They will also organize rally gate meeting at their places. Other members of BSNLEU, mainly of CGMT, CTO, TCO, Kolkata Districts and nearby districts of Kolkata will join enmass in the Dharna from 1400hrs centrally at East side of Circle Office.

All the District/Branch secretaries are requested to take all out effort to make the Strike and Dharna programme a grand success.

Wage Revision : The Management Committee has approved the Wage Revision Committee Recommendation of non-executives. It will now be placed before the BSNL Board, meeting of which will be held tentatively on 23rd/24th February, 2010. Thereafter it will go to DOT.

Promotion Policy : The Promotion Policy(without the 9200-13,200 pay scale) is included in the agenda of the Management Committee meeting which held on 10th February, 2010 for its approval. It is informed that Management Committee held on 10th February, 2010 decided to wait for DPE approval for implementing Promotion Policy. BSNLEU has once again demanded that the policy be implemented with out waiting for DPE approval

Anomaly Committee : It is informed that the implementation of the recommendation of Anomaly Committee for which agreement was signed previously will be approved by the Management Committee meeting which will be held shortly.

TM Examination : Com. Biplab Das, Organising Secretary (CHQ) discussed the matter with V.A.N. Namboodiri, G.S. BSNLEU regarding the eligibility of RM cadre without any qualification like Group-D to appear in the Departmental Examination for promotion to Telecom Mechanic. The matter was discussed with GM(Estt.) on 10th Feb.,10 and a letter is being issued to GM(Estt.) in this regard.
