Comrades,

An emergent meeting of the Circle Office bearer was held on 19.02.2010 at CTO, Kolkata. Comrade Parimal Sarkar presided over the meeting. After detail discussions on various issues following decisions were taken for early implementation:

(a) **Demonstration programme on 3<sup>rd</sup> March, 2010**

It is decided that the Circle Union will organize massive demonstration programme on 3/3/2010 in front of the chamber of CGMT, WB Circle office for settlement of the problems of Civil Wing, QA, Malda & Krisnagar. District & Branch secretaries in and around Kolkata are requested to attend the demonstration programme at 1300 hrs with maximum no. of members.

(b) **Demonstration & Rally on 5<sup>th</sup> March, 2010.**

Bhopal CEC meeting has taken a decision that there will be massive demonstration programme on 5/03/10 through out the country against - **Price Hike** (ii) **Disinvestment of PSUs**  
It is decided that there will be massive demonstration programme in all the BSNL exchanges/offices through out West Bengal and Sikkim on 5/03/10. District/Branch Secretaries are requested to organise the programme with all seriousness. In Kolkata in addition to demonstration programme a rally will be organised.

(c) **Other important Informations.**

1. BSNL management committee meeting will be held on 24/02/10 in which it is expected that 4 Promotion policy matter (except 9200 pay scale) may be finalised.
2. It is expected that BSNL Board meeting will be held in the month of March to finalise wage agreement for the non-executives of BSNL.
3. All India Conference of BSNLEU will be held on & from 12/5/10 to 15/05/10. District Secretaries will know the number of delegates for their District in the next issue of Tele Crusader. They are requested to elect their delegates and purchase their tickets immediately and inform the Circle Union accordingly.
  - (a) BSNLEU will observe Protest Day on 17<sup>th</sup> March'10 demanding TSM status to eligible Casual workers, revision of wage for Casual/Contract workers and demanding Social Securities including EPF,ESI to the non-regular workers.
  - (b) It is decided in the CEC meeting Bhopal that 22<sup>nd</sup> March'2010 will be observed 9<sup>th</sup> Anniversary of BSNLEU anniversary day. Social commitment activities like providing books for poor meritorious student, providing spectacles to the poor old aged persons, blood donation camp etc. etc.
  - (c) It is decided to form AIBDPA at every SSAs/Circles immediately.
  - (d) Suggestion sought for Compassionate Ground Appointment from the Circle Union well in advance before AIC.
  - (e) It is decided in the CEC Bhopal donation will be collected for Union Building fund.
